Abstract: The Pine Flat School, Texas County, Missouri Records contain a microfilm copy of the records of School District No. 129, known as Pine Flat School, which was located north of Eunice in eastern Texas County, Missouri. Included are records of the district clerk, teacher's registers of attendance, and reports of teachers to the county superintendent of schools.

Historical Note:

Pine Flat School was located in Township 29 and 30 North, Ranges 7 and 8 West in eastern Texas County. Formerly School District No. 3, the district was re-designated District No. 129 in 1907.

Scope and Content Note:

District Clerk Records

This series contains the records of the Pine Flat School, Texas County, Missouri district clerk. The records of the district clerk, which span from 1896 to 1924, include minutes of annual meetings of the district and of the board of directors, teachers' contracts, oaths of the directors, enumerations of students and taxpayers, and financial records. There is a gap in the clerk's records beginning in 1909 and continuing into 1911. This series is arranged in chronological order.

Teacher Registers

This series consists of the Pine Flat School teacher registers. The teachers' records include registers of attendance and standing following the Welch System of supervision. The records are complete from 1909 through 1936. This series is arranged in chronological order.

Teacher Reports

This series includes the reports by teachers of Pine Flat School to the county superintendent of schools, which span from 1936 to 1941. This series is arranged in chronological order.
