Historical Note:

The land for the Coffey School was donated by James Coffey in 1885. It was located about nine miles west of Houston, Missouri. The school district was originally known as School District Number 3 before changing to Number 79. The school was consolidated with other area schools in Houston around 1961. Coffey School was located in Section 26, Township 31 North, Range 11 West.

Arrangement:

The collection has been arranged in its original order.

Scope and Content Note:

The records of Coffey School consist of district clerk records and teacher's register of classes. The district clerk's records include lists of board members, oaths of directors, minutes of annual meetings of the school, and records of warrants issued spanning the years 1936 to 1950. The teacher's register includes records of attendance, comments on the progress of students, term statistics, a census of classes by age, and monthly summaries of enrollment, with span dates from 1938 to 1942.
