Abstract: The Ernest Calloway Papers contain correspondence, speeches, public statements, reports, campaign materials, newspapers, and photographs documenting Calloway's activities as president of the St. Louis NAACP, political analyst for Teamsters' Local 688, political activist in St. Louis, and lecturer on urban affairs for St. Louis University.

Biographical Note:

Ernest Calloway was born in Heberton, West Virginia, in 1909. His family moved to the coalfields of Letcher County, Kentucky in 1913 as one of the first Black families in the coal mining communities of Eastern Kentucky. His father helped organize the first local United Mine Workers' union in Letcher County. Calloway attended high school in Lynchburg, Virginia. He quit school and ran away to Harlem in 1925, during the time of the New Negro Renaissance. He worked as a dishwasher in Harlem until his mother fell ill when he returned to Kentucky at age 17. Calloway worked in the mines of Consolidated Coal Company until 1930. During the early 1930s, he traveled around the United States and Mexico as a drifter. After a frightening hallucinatory experience in the mountains of Baja, California, in 1933, he returned to the coal mines of Kentucky.

That same year Calloway submitted an article on marijuana use to *Opportunity*, the magazine of the National Urban League. Opportunity rejected Calloway's manuscript but asked him to write another article on the working conditions of African Americans in the Kentucky coalfields. Calloway submitted the second article "The Negro in the Kentucky Coal Fields", and Opportunity published it in March 1934. The article resulted in a scholarship to Brookwood Labor College in New York, a training facility for labor organizers headed by the radical pacifist, A.J. Muste.

From 1935 to 1936, Calloway worked in Virginia and helped organize the Virginia Workers' Alliance, a union of unemployed Works Progress Administration workers. In 1937, he moved to Chicago and organized railway station porters (redcaps) and other railroad employees into the United Transport Employees Union. Calloway helped write the resolution creating the 1942 Committee Against Discrimination in the CIO. When the first peacetime draft law came into effect in 1939, Calloway was the first African American to refuse military service because of race discrimination. The case received national publicity but was never officially settled. Calloway never served in the Jim Crow Army. Calloway joined the National CIO News editorial staff in 1944.

In 1946, he married DeVerne Lee, a teacher who had led a protest against racial segregation in the Red Cross in India during World War II (see collection S0012). The following year, he received a scholarship from the British Trade Union Congress to attend Ruskin College at Oxford, England, but by the time it was granted, Calloway began working with the CIO Southern Organizing Drive in North Carolina. Because of a dispute over organizing tactics in an attempt to unionize workers at R.G. Reynolds Tobacco Company, Calloway left the CIO in 1950 and returned to Chicago. There, he was enlisted by Harold Gibbons of the St. Louis Teamsters union to establish a research department for the Teamsters in St. Louis.

Calloway canceled his Fulbright scholarship. He had discovered that Local 688 was creating programs for health, housing, and recreation for its members, contributing as much to the social

environment of workers as it did to adequate working conditions. In 1951, Calloway advised the rank-and-file union committee that developed a plan to integrate public schools in St. Louis. The Teamsters presented it to the St. Louis Board of Education three years before the Supreme Court decision on integration. The Board rejected the proposal.

In 1955, Calloway was elected president of the St. Louis branch of the National Association for the Advancement of Colored People. Within the first two years of his presidency, membership grew from 2,000 to 8,000 members. He led successful efforts to gain substantial increases in the number of African Americans employed by St. Louis taxi services, department stores, the Coca Cola Company, and Southwestern Bell. The NAACP opposed a proposed city charter in 1957 because it did not include civil service reforms, public accommodations sections, or support for civil rights. The charter was defeated.

Calloway served as campaign director for the Reverend John J. Hicks in 1959. Hicks subsequently became the first African American elected to the St. Louis Board of Education. Calloway also directed the campaign for Theodore McNeal's 1960 senatorial race. McNeal won by a large margin, becoming the first African American elected to the Missouri Senate. The following year Ernest and DeVerne Calloway began publishing *Citizen Crusader* (later named *New Citizen*), a newspaper covering African American politics and civil rights in St. Louis. Also, in 1961, he was the technical advisor for James Hurt, Jr.'s successful campaign as the second African American to be elected to the St. Louis School Board. DeVerne Calloway became the first Black woman elected to the Missouri Legislature in 1962 when she won a seat on the House of Representatives on her first bid for public office.

Calloway worked with the Committee on Fair Representation in 1967 to develop a new plan for congressional district reapportionment. Supported by Black representatives in the Missouri Legislature, and a coalition of white Republicans and Democrats, the plan created a First Congressional District more compatible to African American interests. In 1968, Calloway filed as a candidate for Congress in the new district. He was defeated in the Democratic primary by William Clay, who became the first African American elected to Congress from Missouri.

The following year, Calloway began lecturing part-time for St. Louis University's Center for Urban Programs. He became an assistant professor when he retired as a research director for the Teamsters in June 1973. He later became Professor Emeritus of Urban Studies at St. Louis University. Calloway suffered a disabling stroke in 1982 and died in 1989.

Scope and Content Note:

Personal Papers

This series contains biographies, correspondence, and speeches relating to Ernest Calloway's personal life, schooling, and his extracurricular activities. Notable inclusions to this series are correspondence regarding *New Citizen*, a newspaper published by Ernest and DeVerne, and a history of the Consolidation Coal Company. The materials in this series date from 1934 to 1982 and are arranged chronologically.

Labor

This series contains articles, correspondence, meeting minutes, reports, newspaper clippings, and pamphlets documenting Ernest Calloway's involvement in the Labor Movement in St. Louis. Subjects of interest include Israeli unionism, Black unionism, the Negro American Labor Council, the International Brotherhood of Teamsters, and United Transport Service Employees. Materials of note include the *Histadrut Newsletter*, a publication documenting the struggles of Israeli workers in their attempts to unionize. The materials in this series date from 1940 to 1980 and are arranged alphabetically with two subseries: International Brotherhood of Teamsters and Negro American Labor Council.

The International Brotherhood of Teamsters subseries contains articles, correspondence, newspaper clippings, and pamphlets, documenting Ernest Calloway's leadership activities in the Central Conference of Teamsters. Notable materials include correspondence and statements regarding the Construction Strike of 1953 involving Local 682, as well as correspondence, reports, and speeches for Local 688. The materials in this subseries date from 1946 to 1980 and are arranged alphabetically.

The Negro American Labor Council subseries contains a constitution, convention programs, meeting minutes, membership lists, newspaper clippings, press releases, and reports documenting the governance and activities of the Negro American Labor Council. The subseries also contains handouts for leadership and training courses held in conjunction with Teamsters Local 688. Material of note include correspondence, flyers, and pamphlets regarding the Negro American Labor Council's involvement in the March on Washington on August 28, 1963. The materials in this subseries date from 1958 to 1983 and are arranged alphabetically.

Political

This series contains articles, correspondence, newspaper clippings, notes, pamphlets, and ward boundary maps regarding St. Louis' political spectrum. Materials of note include event programs

for the Democratic Ward Christmas Charity Dance. Topics of interest include congressional reapportionment, Black politics, and St. Louis boards of commissions.

Included is a Campaigns subseries which contains election results, statistics, and summaries regarding local, state, and national elections. Additionally, this subseries contains articles, correspondence, newspaper clippings, and pamphlets for not only Ernest Calloway's political campaigns, but also campaigns which Calloway directed, including Theodore McNeal's senatorial campaign and John J. Hick's campaign for the St. Louis Board of Education. Also documented are Jimmy Carter's presidential campaign, the Morse-Humphrey presidential campaign, and the Tucker-Cervantes mayoral campaign.

The materials in this series date from 1934 to 1984 and are arranged alphabetically.

Civil Rights

This series contains articles, correspondence, legislation, reports, and statements of purpose discussing the equality, equity, rights, and discriminations of African Americans and other marginalized communities. Materials of note include correspondence, newspaper clippings, and press releases regarding the March on Washington that took place in 1942 to pressure the United States government to establish protections against employment discrimination. The materials in this series date from 1942 to 1979 and are arranged alphabetically.

National Association for the Advancement of Colored People – St. Louis

This series contains correspondence, meeting minutes, pamphlets, press releases, programs, and reports regarding the activities of the St. Louis branch of the National Association for the Advancement of Colored People (NAACP). Also discussed within the series are issues with which NAACP was involved including hiring and labor discrimination. Materials of note include issues of *Honor Guard*, an NAACP-St. Louis membership directory, as well as lists of the St. Louis branch's presidents and officers from 1914 to 1972. Also documented is Ernest Calloway's involvement with NAACP. The materials in this series date from 1914 to 1983 and are arranged alphabetically.

Community and Urban Affairs

This series contains correspondence, meeting minutes, newspaper clippings, pamphlets, statistics, and studies documenting Calloway's involvement in St. Louis City and County's community, municipal, and city organizations whose efforts were focused on improving St. Louis communities. Topics of interest include child welfare, housing, urban development and restoration, education, economics, and healthcare. The materials in this series date from 1953 to 1986 and are arranged alphabetically.

Teaching Resources

This series contains newspaper clippings, reports, and statistics, which Ernest Calloway used as resources for teaching Urban Studies at Saint Louis University. The classes Calloway taught include The Urban Black and Black Metropolis. Materials regarding these classes include syllabi, student papers, and schedules. Student essays discuss urban development, poverty, racism, civil rights, education, and employment. The materials in this series date from 1951 to 1982 and are arranged alphabetically.

Publications

This series consists of three subseries which document the religious, social, and political environments during the mid-1900s. The subseries includes Church Programs, Newspaper Clippings, and Newspapers. Also included in this series is Ernest Calloway's book entitled *Architects of an Unfinished American Dream*.

The Church Programs subseries documents the histories and events of African American churches in the St. Louis area. Some notable churches covered in this subseries include St. Paul African Methodist Episcopal Church, Central Baptist Church, Antioch Baptist Church, and Prince of Peace Gospel Church. The programs in this subseries date from 1921 to 1978 and are arranged chronologically.

The Newspaper Clippings subseries documents major events, people, and issues in St. Louis. Most of the newspaper articles in this subseries were written by Ernest Calloway and compiled into a series of topics. Notable topics include the labor movement, politics, race, economics, poverty, and public services such as housing and education. Calloway also compiled newspaper clippings on William Clay, Benjamin Goins, and Jimmy Hoffa. The newspaper clippings in this subseries date from 1934 to 1985 and are arranged alphabetically by subject.

The Newspapers subseries contains full issues of several newspapers including *Missouri Teamster*, *New Citizen*, *Truth*, and *St. Louis NAACP Citizen*. Many of the newspapers in this subseries only contain one or two issues, such as the *AME Christian Recorder*, *4th Ward Citizen*, *18th Ward Democrat*, and *16th Ward Citizen*. The newspapers date from 1957 to 1977 and are arranged alphabetically.

Photographs

This series consists of photographs depicting Ernest Calloway's involvement in the labor, political, social, and economic spheres. Notable organizations and individuals depicted in the photographs include Margaret Belafonte, Margaret B. Wilson, Fred Weathers, DeVerne Calloway, Benjamin Goins, Theodore D. McNeal, Lyndon B. Johnson, United Transportation Service Employees, National Association for the Advancement of Colored People, and Central Conference of Teamsters. Also included in this series are photographs which were used in *New Citizen*. The photographs in this series date from 1934 to 1986 and are arranged by identified photographs, then unidentified photographs.

Plaques and Certificates

This series contains certificates, awards, and recognitions which Ernest Calloway accumulated over his career in labor, politics, and community involvement. The materials in this series date from 1953 to 1988 and are arranged chronologically.

Audio Tapes

This series contains eight reel-to-reel tapes discussing topics such as war, Black leaders in St. Louis, civil rights, and politics. The reel-to-reel tapes are mostly undated with one tape, "Ward politics discussion," being dated 1959. The materials in this series are arranged alphabetically.

Oversize

This series contains certificates, political posters, a labor newspaper clipping scrapbook, and a bound volume of *Citizen Crusader* and *New Citizen* newspaper issues. The posters' subjects include Benjamin Weathers' Clerk of Criminal Corrections election, Ernest Calloway's congressional election, and Jimmy Carter's presidential election. The materials in this series date from 1954 to 1989 and are arranged alphabetically.
