**Abstract:** The collection contains ordinances and meeting minutes relating to the City of Florissant, Missouri and its operations. The city was founded in 1785 and is one of the oldest settlements in Missouri. The minute books include copies of official correspondence, council rosters, budgets, resolutions, certificates of appointments, and maps.

#### **Historical Note:**

Florissant was established as a village in 1786 under Francois Dunegat dit Beaurosier, the civil and military commandant during the entire Spanish regime. It is one of the oldest settlements in Missouri, having first been settled around the same time as St. Louis. The majority of early settlers were of Canadian descent, with French the recognized language of the village. Old St. Ferdinand's Church was built in 1789. In 1829, Florissant became an incorporated town and in 1857, the Missouri Legislature granted a city charter with the corporate title of the City of St. Ferdinand. The popular use of Florissant persisted, however, and in 1939, the citizens voted officially to change the name to the City of Florissant, Missouri.

## **Scope and Content Note:**

The records contain ordinances and meeting minutes books which include copies of official correspondence, council rosters, budgets, resolutions, certificates of appointments, and maps. Ordinance Books indicate bill numbers. The records are divided into two series: Ordinances, 1857-1878 and 1901-1965, and Council Meeting Minutes Books, 1878-1973. Ordinances from 1965 are included in the Council Meeting Minutes Books. Ordinances are found in rolls 1, 2, & 3; and Minute Books in rolls 1, and 4-9.

#### **Ordinances and Council Meeting Minutes**

This series contains ordinances related to city codes established throughout the middle-to-late 1800s and early-to-middle 1900s. The ordinances include papers on incorporation and city zoning, among others. Also included are early meeting minute books. The materials in this series date from 1857 to 1878 and 1901 to 1965 and are arranged chronologically.

#### **Council Meeting Minutes Books**

This series consists of materials pertaining to city council's meeting minutes. Included in the meeting minutes are correspondence, council rosters, budgets, resolutions, certificates of appointment, and maps. The materials in this series date from 1878 to 1973 and are arranged chronologically.
