In April, 1981, Dr. A.C. Phillips, the president of New Age Federal Savings and Loan Association, gave New Age's records to the University of Missouri-St. Louis' Black History Project. They were microfilmed and placed with the Western Historical Manuscript Collection.

New Age Federal Savings and Loan Association was founded in 1915 by a group of black community leaders to provide loans to black St. Louisans to build or buy homes at a time when St. Louis banks and financial institutions consistently refused to make such loans. The association has played a major role in extending credit to individuals, organizations, businesses and churches in St. Louis.

The New Age Federal Savings and Loan Association records include correspondence, minutes, reports, newsletters, and programs.
