Historical Note:

In the summer of 1979, the Sunbelt Alliance, an antinuclear power group in Oklahoma, contacted the St. Louis Peace and Freedom Party about organizing protests against the Union Electric Company's nuclear power plant in Callaway County, Missouri. The Sunbelt Alliance had conducted successful civil disobedience actions against the construction of the Black Fox Nuclear Power Plant in Oklahoma and had learned that the Peace and Freedom Party was interested in organizing similar protests. After attending Sunbelt Alliance-sponsored training sessions in non-violent civil disobedience, the Peace and Freedom Party reorganized as the Crawdad Alliance in August 1979, taking its name from a Missouri crustacean.

The Crawdad Alliance held meetings and fundraising benefits, as well as distributing leaflets and newsletters alerting the public to the dangers of nuclear power. During its brief existence, the Crawdad Alliance also coordinated with other Missouri anti-nuclear power groups to protest Union Electric's construction of the Calloway Power Plant, located in Calloway County, Missouri, through civil disobedience. On March 29, 1980, Crawdad Alliance leaders led 90 protesters to the Calloway Power Plant on the anniversary of the Three Mile Island crisis. Twenty-six of the marchers trespassed on Union Electric property and were arrested by the Calloway County Sheriff's Department. The Crawdad Alliance remained active in the antinuclear movement throughout the early 1980s.

Scope and Content Note:

Records of the Crawdad Alliance including leaflets, flyers, handbooks, issues of the *Crawdad Cabal* newsletters, and a July 1981 edition of the *St. Louis Mirror* newspaper concerning the Union Electric Company's Calloway Power Plant in Calloway County, Missouri, including plans for peaceful demonstrations to block the construction of the plant; civil disobedience and non-violence training for Alliance members; health hazards relating to nuclear power; the Sunbelt Alliance's nonviolent protests of the Black Fox Nuclear Power Plant in Oklahoma; and the Three-Mile Island incident in Harrisburg, Pennsylvania, in 1979.
