Abstract: The Sarah Cornelia Williams Diaries contains microfilmed daily diary entries by Sarah Cornelia Williams. The entries document everyday life as a mother and wife in St. Louis and references to the election of Abraham Lincoln, the Civil War, and the Great Chicago Fire of 1871.

Biographical Note:

Sarah Cornelia Williams was born on November 30, 1817, to Hezekiah Conn and Isabella Richard Buck in Virginia. She married Frederick A. Williams, a grocery and notion store clerk, on March 6, 1838, in St. Louis, Missouri. The couple settled in Boonville, Missouri, and had their first two children: John C. Williams and Williams S. Williams. During the 1840s, the Williams family relocated to Worchester County, Maryland, and had four more children: Alice M. Williams (1848-1874), James L. Williams (1850-1930), Wayman P. Williams (1856-1909), and Cornelia Ann Williams. In the early 1860s, the family relocated to St. Louis City and had their last child, Lillie M. Williams. Sarah and Frederick Williams relocated to Montrose, Missouri, in 1880. On December 20, 1880, Sarah Cornelia Williams died in Montrose, Missouri.

Scope and Content Note:

This collection contains eight daily diaries written by Sarah Cornelia Williams from 1845 and 1863 to 1880. Sarah's diaries primarily document her day-to-day life in St. Louis, including topics such as knitting clothes for her children, expressing her displeasure with the housekeeper's cleaning skills, and dining with family and friends. Aside from family life, the diaries also contain brief mentions of Union soldiers passing through St. Louis during the Civil War, the election of Abraham Lincoln in 1864, and how dusty and smoky St. Louis was in the aftermath of the 1871 Great Chicago Fire. The diaries have been microfilmed chronologically onto one reel.
