The Elizabeth Terry Papers consists of book drafts, CD-ROMS, cassette tapes, correspondence, manuscripts, interview summaries, photographs, and photocopies of correspondence and newspapers articles regarding Terry's research and writing of her book *Oysters to Angus: Three Generations of the St. Louis Faust Family*. The book recounts the lives of Anthony "Tony" Faust (January 3, 1836-September 28, 1906), a prominent St. Louis City restaurateur and owner of Faust's Fulton Market; his son, Edward Faust (January 13, 1868-July 5, 1936), founder of the St. Louis Boat and Engineering Company; and his grandson, Leicester Busch Faust (December 22, 1897-August 31, 1979), a prominent St. Louis County farmer, who along with his wife, Mary Plant, donated 200 acres of their land to St. Louis County for what eventually became Faust Park, in Chesterfield, Missouri.

The collection consists of two components--Digital and analog files. The digital files are grouped alphabetically into ten groupings—Bibliography, Book, Bluebird Publishing, Books sales, events, and lectures, Elizabeth Terry biography and headshot, Faust photographs, Faust project notes and research, Publisher submissions, St. Louis Magazine, Faust Family, and Stein. The materials in this section chronicle Terry's research, writing, and promotion of the book from 2008 to 2014. Items of interest consist of the first and second drafts of *Oysters to Angus*, including notes and comments from her editors. Also included in the digital files are summaries of interviews Terry conducted with associates and friends of the Faust family, including Allen Sellenriek, whose father, Fred Sellenriek managed Leicester Faust's farm. The digital files date from 2007 to 2017.

The analog files consist of four groupings: Anthony Faust, Edward Faust, Leicester Faust, General research, and Oversize materials. The materials found in the textual files are mostly photocopies of newspaper clippings, photographs, and census and probate records featuring the Faust family, some of which contain Terry's handwritten notes. Items of interest include photos of Terry standing next to the graves the Faust family. Terry photocopied the majority of these materials from 2008 to 2011, the dates of her active research on the Faust family; the contents date from the 1860s to the early 2000s.

Elizabeth Terry is a St. Louis area historian and professional researcher. She began her career in history in Richmond, Virginia, as a historical programmer for the Maymont House Museum in 2001, after earning her bachelor of arts from the University Nebraska at Kearney, in 1997, and a master of arts in history from James Madison University in 2000. Terry moved to the St. Louis area in 2006-2007 and established Elizabeth Terry Historical Research, specializing in conducting historical research and writing for clients. In April 2014, Bluebird Press released her first book, *Oysters to Angus: Three Generations of the St. Louis Faust Family*.
