### **Biographical Note:**

Charles 'Charlie' Henry Howerton was born in Noel, Missouri, on June 18, 1911, to John W. Howerton and Cora R. Howerton. He lived, married, and worked in Noel and Southwest City, Missouri, for the majority of his life. He married his wife Marie Benefiel in Noel on June 25, 1929. They had three children: Charlene Howerton Wallace, Wesley Howerton , and Sue Howerton Victoria. Charlie worked on farms at different points in his life, including in Noel and Southwest City. He drove fuel trucks for Pick out of Southwest City, Missouri, during the 1930s and into the 1940s. Around 1942, Charlie bought the business and continued driving trucks while running the business.
