Historical Note:

Henry C. Young was born in Kentucky in 1834. He married his wife Belle in the late 1850s, and they had four children together, Graham, Henry, Robert, and Gabriel. Henry was a successful Springfield lawyer, whose office was located in City Hall. He died in 1882 at the age of 48.

Basil (Chris) E. Buterbaugh was born April 1, 1926, the son of Basil E. Buterbaugh and Jewell Butterbaugh. He graduated from Rich Hill High School and in 1950 earned a degree in mining engineering from the Missouri School of Mines and Metallurgy, currently the Rolla Institute of Science and Technology. He married Jonina Mae Parkison on Septemer 9, 1949. Together they had three children, Phillip Basil, Keith Martin, and Mark Allen. The couple lived most of their lives in Springfield, where Chris worked 34 years as a civil engineer for the Frisco and Burlington-Northern railroads. Chris served as committee chairman of the Downtown Kiwanis Club, volunteered for the Salvation Army and the Boy scouts. He died on December 1, 2013. Jonina died in 2020.

Arrangement:

This collection has been arranged by property in three folders.

Scope and Content Note:

The collection contains abstracts for three properties located in Springfield, Missouri. One property was owned by Springfield attorney Henry C. Young and the abstract includes his will. The other two properties were owned by the Buterbaugh family whose home was located at 2400 S. McCann. They also owned a home in the Rosewood subdivision in Springfield.
