Biographical Note:

Norman William Smith was born February 26, 1925, in Doniphan, Missouri, to Walter E. Smith and Pearl R. *Fagan* Smith. From 1943 to 1946, Norman served in the United States Navy during World War II aboard the U.S.S. Carter Hall #3. He married Marjorie Ellen Stone on May 26,

1951, in Bay, Arkansas. The couple had two children, Ellen Sue Smith and Norma Lee Smith. Norman died April 5, 2012, in Doniphan, Missouri.
