Historical Note:

The Chatham Mining Company were the successors to the Tracy Lead and Zinc Mining Company, located in Webb City and Carterville, Missouri. The change in ownership occurred April 1, 1892. The company was one of the largest producers in the country, with 27 mines in operation and shafts averaging 150 feet deep while employing over 300 men.

The document includes 30 pages outlining the lawsuit between the plaintiff and defendants over a salary dispute. Plaintiff, Julius A. Hewitt, accuses the defendants of the Chatham Mining Company, Albert E. Tracy, D. E. Tracy, James Smith, and George McClellan, of mismanaging funds and employee salaries.
