Biographical Note:

Evald Ludwig Berndt was born September 9, 1840, in Hällefors, Sweden. He came to America in 1868 and worked in the pineries of Michigan. Later that year, Berndt moved to Moline, Illinois, and began working for Moline Plow Company. He married Margaret Westlund on May

23, 1871. Margaret Westlund Berndt was born September 12, 1845, in Gävleborg, Sweden. She came to America in 1866. Evald and Margaret had eleven children: Dorothea, John, Anna, Ludwig, Phoebe, Jonathan, George, and Haudy. Along with Hattie, two other infants did not survive to adulthood. Margaret died August 7, 1896, in Moline, Illinois. Evald died April 15, 1909, in Moline, Illinois.

Ann Charlotte Berndt was born March 7, 1879, to Evald and Margaret Berndt in Moline, Illinois. She married John Nelson on November 27, 1913. The couple had one daughter, Vivian Berndt Nelson, who was born January 6, 1918. Ann died March 22, 1961, and is buried at Rockaway Cemetery in Moline, Illinois. Vivian Berndt Nelson married Albin Willard Larson on December 27, 1948. The couple had three children, including a daughter, Nancy Larson Alexander. Vivian died December 12, 1999, in Moline, Illinois.

The Berndt family owned property in Wright County, Missouri, from 1893 to 1910. The property was located in Section 15, Township 28, Range 13 West, and contained about 160 acres. The land originally belonged to Peter Colson of Wright County. The Berndt family sold the property to L.D. Caudle in 1910.

Arrangement:

The collection has been arranged into six folders and kept in their original order.

Scope and Content Note:

This items in the collection pertain to the Berndt and Westlund family of Rock Island, Illinois, as well as property located in Wright County, Missouri. The collection includes a Homestead Certificate from the Springfield, Missouri, Land Office, a warranty deed signed by Evald and Margaret Berndt, a letter and corresponding land transfer deed, and obituaries.

This collection also includes copies of two Rock Island, Illinois, Pioneer Descendant certificates presented to Vivian Berndt Nelson Larson and Nancy Larson, and a handwritten letter from Nancy.
