Historical Note:

The Southwest Missouri Library Service, Inc., was founded in October of 1957 as a processing center in Bolivar, Missouri. The non-profit corporation was governed by an executive board and financed on a pro rata basis according to each member library's income. Using grant-funded equipment from the Council on Library Resources, the processing center would process, catalog, and ship books to member libraries. Member libraries included: Barry-Lawrence Regional Library, Barton County Library, Boonslick Regional Library, Carthage Public Library, Cass County Library, Christian County Library, Eldon Public Library, Fayette Public Library, Greene County Library, Joplin Public Library, Kinderhook Regional Library, Little Dixie Regional Library, Livingston County Memorial Library, Mexico-Audrain Public Library, McDonald County Library, Moberly Public Library, Newton County Library, Southwest Regional Library, Springfield Public Library, Stone County Library, Town and Country Regional Library, and Trails Regional Library.

Southwest Missouri Library Service, Inc., was one of the first organizations to provide processing services to public libraries on a membership basis. It received national acclaim for its contribution to the library field and was the subject of multiple studies published by the Council on Library Resources and The Library Research Center at the University of Illinois. Due to membership decline, budget constraints, and rising costs of the Online Computer Library Center (OCLC), the Southwest Missouri Library Services, Inc., disbanded in 1981.

Scope and Content Note:

Administrative Records

This series contains the administrative records of Southwest Missouri Library Service, Inc. Items include Articles of Association, by-laws, membership contracts and policies, insurance records, and the organization's records of employment. This series also includes board meeting minutes from 1957 through 1981. This series is arranged by subject and then chronologically.

Correspondence

This series consists of correspondence to and from Southwest Missouri Library Service, Inc. The correspondence includes letters from member libraries, vendors, government entities, and professional organizations like the American Library Association. This series is arranged chronologically.

Financial Records

This series contains the financial records of Southwest Missouri Library Service, Inc. The materials consist of budget reports, financial statements of member libraries, and audit reports compiled by professional accountants. This series also includes financial records specifically pertaining to Online Computer Library Center (OCLC). This series is arranged by subject and then chronologically.

Membership

This series consists of materials related to Southwest Missouri Library Service, Inc.'s membership such as newsletters, promotional materials, and two photographs. The photographs are candid in nature and do not identify the individuals being photographed. The promotional materials include correspondence, brochures, and images of Southwest Missouri Library Services, Inc., operations. This series is arranged by subject and then chronologically.

Publications

This series contains newspaper clippings and articles written about Southwest Missouri Library Services, Inc., including the organization's history, operations, and members. This series is arranged by format and then chronologically.

Research Studies

This series consists of two research studies conducted by the Council on Library Resources and The Research Library at the University of Illinois. The studies are denoted as "surveys" and report on all facets of Southwest Missouri Library Service, Inc., from its founding in 1957 to 1961 when the studies were completed. This series also contains the beginnings of a survey conducted by Jewel Hardkopf in 1961, however, the survey was never completed. This series is arranged by survey name and then chronologically.
